Re: FY20 CAC funding to Nashua Senior Center

The Citizens Advisory Commission for Community Grants (CAC) evaluates proposals from non-profits that serve Nashua residents. The seven Commissioners review all proposals and make funding recommendations to the Mayor. These recommendations are then included in the Mayor's annual proposed budget. The awards are approved through the budget process and ultimately adopted by the Board of Aldermen.

The Nashua Senior Center submitted a request (attached) to change their \$11,169.00 award from a part-time Community Outreach Liaison to general operations.

The CAC met on June 30, 2020 and voted to approve this change in use of funds. They further requested that the Nashua Senior Center provide a brief report on current operations, plans to reopen and what line items the funds will cover. That report will be provided to the CAC in advance of future allocations (as is required of all awardees).

The change in use of funds does not affect the amount in the adopted budget. The CAC conducts open and public meetings for which the agendas and minutes are available on the City's website. This communication serves as an additional measure to add the change to the public record.

Dear Carrie,

I hope this finds you well.

I wanted to follow-up on our conversation from a couple of weeks ago. As you are aware, the Nashua Senior Activity Center was the fortunate recipient of funding from the Citizens Advisory Committee in 2019. This grant of \$11,169.00 was to support a part-time position for a Community Outreach Liaison for the organization. The hire was put on hold until our Personnel Policy Hand Book could be updated.

The Nashua Senior Activity Center has been closed since March 13, 2020. We are proud of our "self-standing" status however we have lost nearly every revenue stream including programs, travel, rentals, retail and some of our fundraisers. In fact, our largest fundraiser, Fire and Fusion, scheduled for May 6 has been postponed until fall. And, at this point, I am not sure if that event will be able to take place. Staff has been working remotely and we are certainly not in a position to hire at this time.

As mentioned in our conversation, I am requesting that the Committee allow us to change the need and reallocate funds so we may put them in our general account to support the Center. We were not eligible for the City program that was released a couple of weeks ago that gave funding to non-profits, so this "need change" would be truly beneficial and greatly appreciated.

Please advise of the next steps I should take.
