Concerns have been raised about the perceived speed of traffic, in the area of the Saint Christopher Elementary School, with the presence of children in the street. Although stop signs are not a traffic calming device, they have been requested in this instance by local residents in an effort to ease concerns relative to the safety of children in this area. Stop signs are currently present on both Dinsmore Street approaches, stop signs are proposed to be added to the Douglas Street approaches to establish an all-way stop condition.

The vehicles entering the Dunkin' restaurant at 471 Amherst Street, at times, have been backing up into the Amherst Street Right of Way. In addition, tractor trailer trucks have been observed parking in the Amherst Street shoulder west of the Dunkin' driveway while they access the restaurant by foot. These conditions present a potential safety hazard for motorists, block the usage of the shoulder by bicyclists and others, and impede the use of the shoulder for other purposes (such as emergency use). The Division of Public Works is proposing the restriction of parking, stopping and standing in this area to address these concerns directly. The proposed ordinance restricts parking from the driveway at 485 Amherst Street to a point 200-feet east of the 471 Amherst Street driveway.

There is a driveway to a residence on the west side of the intersection of Conant Road and Searles Road. When the residents attempt to exit this driveway, they cannot see traffic approaching the intersection from the north as they have very limited sight distance. The Division is recommending the installation of a stop sign at the northwest corner of this intersection to bring the westbound Conant Road approach under stop control. Currently, the eastbound Conant Road and northbound Searles Road approaches are stop controlled. The stop sign is allowed per the MUTCD based on an exception where motorists lack the available sight distance to see approaching cross street traffic. This all-way stop intersection addresses the sight distance issue directly as traffic approaching from the north will come to a stop where the residents can see them prior to entering the intersection.

The traffic circulation patterns are being changed around the Franklin Street School in an effort to improve safety for motorists and pedestrians.

Some of the changes include the following:

- Change Franklin Street, from Locust Street to Charles Street, to a one-way street in the westbound direction.
- Change Charles Street, from Franklin Street to Terrace Street, to a one-way street in the northbound direction.
- Change Locust Street, from Winter Street to Franklin Street, to a one-way street in the southbound direction.

With this change in traffic circulation patterns, the Division of Public Works believes the Charles/Terrace intersection should be an all-way stop controlled intersection. This will require all motorists to alternate the yielding of right of way after coming to a complete stop. This should reduce any potential confusion by motorists at the intersection thereby improving safety.
