Call to Order 12:35 pm – 1:35 pm

• Minutes from December & February meeting were approved.

1. Director's Report

Operational:

- Restructuring how department reports are reported. Staff will include upcoming
 activities, events and public health issues each month along with brief summary of
 previous month's report.
- Budget Review with the Board of Alderman is next week April 16th,
 - A PowerPoint presentation shows what changes are in departments' budgets.
- Restructuring the remaining administrative assistant position at the Division. The
 request for an administrative position for the Division under the Community Services
 FY 19 budget was not approved.
- Staffing is almost full with the exception of a new nurse low wage offered makes it hard to fill the position with a qualified individual.
- Opioid crises: 1st lady of NY was here last week; Lisa & Bobbie went over to share the approach the Mayor's Opioid Task Force is taking to battle the opioid crises.
- Mayor's Student Internship
 - For 6 weeks over the Summer each Director will have 1-2 paid high school student(s) intern at the Division

2. **Department Summaries**

Community Services

- 1. Epidemiologist:
 - Working on HPV campaign
 - Moving forward in April with collecting data on substance use in Nashua
- 2. Health Promotion Specialist
 - Updated on Public Health week and Employee walking challenge

- Health and Safety Fair at Nashua North High School had about 400 people, 35 vendors. Surveys to be send out
- Assisting in planning the 3rd DPHCS Community Health Department Annual Health Care Conference

3. Public Health Network Services

- CHIP: As only 12 out of 30 PHAC Executive Committee members were in attendance for the prioritization process, members agreed that a survey should be developed to allow those not at the meeting to participate in the prioritization process as well. The PHNS Coordinator created a survey via Survey Monkey and distributed it to the PHAC Executive Committee on March 22. The survey was closed on March 30th and was completed by 6 additional PHAC Executive Committee members, resulting in a total of 18 out of 29 members (62%) participating in the prioritization process. The results of the survey will be compiled and reported out at the May 1. Survey is not done yet & can add more guestions
- PHAC Executive Committee meeting at which members will decide upon goals and objectives for each 2018 CHIP Health Priority.
- Create focus groups for substance abuse hopefully our Epidemiologist can use the research/date collected from Dean started in 2016

4. Environmental Health

- Gearing up for busiest time of year with swimming pools inspections and temporary food inspection
- Banana Leaf, LLC/Biryani Pot License suspended 3/26/18 4/5/18. Multiple critical violations, building violations, and life safety violations. Worked with Building Safety Department and Fire Marshall Office to ensure violations across all departments remediated before reinstatement of license.
- Nashua Crossings Repeated failures. Education to staff given and multiple food service meetings. Currently working on corrective action plan with facility director. Contingency plan required – Patty to look into a COOP plan (CMS Rule)
- Lead bill every water point source in schools will need to be tested. More information to follow.
- DES Public Hearing in Nashua to address update on Asbestos Clean Land Fill to address the changes and re-adoption of disposal ENV-SW2100 site rules.

5. Welfare

- March has seen a noted decrease in the amount of assistance granted to applicants.
- Staff help refer people to apply for assistance through programs to offset the need for Municipal Welfare assistance.
- Assessments have been revamped to help the process be more efficient when interviewing/assessing individuals asking for the assistance.
- Coming in under budget and proposed an increase in rental fees.

 Medicaid expansion plan – certain requirements will be added such as: Citizenship, work requirements minimum of 25 hours, everyone on managed care, & a 90 day retroactive period
