Kerry called the meeting to order at 6:05pm

**Items Discussed:**

1. Adoption of 3/21/19 meeting minutes

**Sylvie moved to accept the minutes as submitted. Justin seconded. All in favor**

2. Subcommittee Updates

- a. Composting- Shoshanna and Gary were not present to update

Kerry mentioned the Garden Club and DPW are doing their annual sale of compost bins, rain barrels, scrap pails and compost turners.

- b. Electric Vehicles

Kerry, Colin and Brendan are on the committee. Kerry has done some research.

Colin and Brendan have spoken to the Souhegan Rotary club and have quartered off the city into areas and have highlighted dining, entertainment, lodging etc. in each area.

The committee discussed adding a layer to the City GIS for charging stations.

- c. Paper Reduction

Deb and Justin stated the plan is to develop a campaign of public outreach towards paper reduction.

They will put together some statistics to share via the city-wide email system. They will also explore and develop some training/options for people to use to cut down printing.

Deb wants to work on making the payroll paper check an opt-in rather than opt-out system, but that won't happen until after focusing on paper reduction.

- d. Single-use Plastic Reduction

Sylvie reported she researched grocery stores in Nashua and Hannaford and Market Basket talked about their recycling, but not bags. Whole Foods has many programs in place. She described the 'Give me 5' program which relates to recycling the level 5 plastics. They also don't supply plastic bags for produce anymore.

Aldi's doesn't use bags, but she didn't speak with them or Shaws.

Arden wondered what the overall goal is.

Sylvie noted if they can find particular businesses that are mindful of these issues and are taking steps, the Mayor could highlight them for their achievements.

Doria found a company called Loop. They send reusable containers with your product and you send the container back for refill/ recycling.

e. Emissions and renewables

Arden said she is waiting to hear back regarding the budget. Deb said the Community Development Department budget came in under budget and there was \$5000 itemized for the EEC. Arden also wondered how she would have access to the money to eventually spend it.

3. Destination Electric

Deb had sent some information around. The marketing company that is spearheading the 7-state initiative put together a list of businesses near charging stations. The approach was to find 'hip' businesses that are on social media. This would attract a certain demographic who might buy electric vehicles.
