Mr. Weber asked what the color of the exhaust stack would be.

Pastor Berube said that they want to paint the exhaust stack in keeping with the rest of the motif of the buildings, so it would be flat black to complement existing motif.

Mr. Weber asked if it will be thermal paint, so it would not burn off.

Pastor Berube said that they would use the appropriate type of paint for it, as they've done that before.

Mr. Weber said that the concern is that it would peel off a few years from now.
