**Items Discussed:**

Since the last meeting in June, Colin and Brendan were sworn in as student members, and Jeff LaFleur will replace Kerry Converse as the DPW Director’s designee.

1. Adoption of 6/20/19 meeting minutes

**Justin moved to accept the minutes as submitted. Sylvie seconded. All in favor.**

2. Justin Monroe –Grow Nashua (<https://www.grownashua.org/>)

Justin Monroe, the Director of Grow Nashua gave a presentation providing details on the mission of Nashua Grows and the composting services they provide. They currently have about 70 houses that they provide composting services to. Each home has a bucket lined with a compostable bag and the buckets are picked up weekly by Grow Nashua. The average pickup is ~13 pounds/week. Over 40,000 pounds of food scraps have been diverted from the trash. Grow Nashua partners with Agri-Cycle who brings the food scraps to a compost farm in Massachusetts.

3. Subcommittee Updates

a. Composting- Shoshanna and Gary

Jeff provided an update on a meeting regarding recycling that took place today. The City does not currently have the capacity to provide curbside composting, nor the ability to maintain/operate a composting facility at the landfill. However, Jeff said there is the desire for DPW to support Grow Nashua as a third party service to the community. The DPW Director and BPW will evaluate whether a DPW truck could be provided to assist Grow Nashua in expanding their composting services.

Jeff indicated that the DPW will take the lead on municipal composting. Doria offered that the committee could support those efforts through social media, legislation, etc.

#### b. Electric Vehicles

Jim, Bob, Colin and Brendan

The City recently installed 2 new electric vehicle chargers in the Elm Street Garage. The original charger there will be moved to a yet-to-be-determined location. The Nashua electric vehicle expo will take place on Saturday September 21<sup>st</sup> at 1pm at the Nashua Public Library. Colin noticed that Brianna Brand at Clean Energy NH is organizing a list of chargers and the Nashua chargers aren't on the list. Colin will follow up with her. Colin and Brendan continue to move their Electrify Nashua project forward with contacting businesses located in areas thought to have easy access for those looking to charge their vehicles.

#### 4. Municipal Solar project

Deb gave an update on the municipal solar project she has been working on with ReVision Energy. The project includes putting rooftop solar on two municipally owned buildings, the Lake Street Garage and the Transit Garage on Riverside Street as well as the Conway Ice Arena. The City is currently reviewing the Power Purchase Agreement. ReVision Energy gave a great presentation to the Board of Aldermen to explain how a PPA works. Still shooting for installation this year. Justin asked about storage batteries. Bob indicated that the pricing on storage batteries has come down recently, but not enough yet to be a good investment.

#### 5. Solarize + campaign organization

Doria volunteered to take the reins on the Solarize+ campaign for next next year. Bob, Arden and Deb volunteered to help.

Doria made a motion to create a Solarize+ Campaign subcommittee. Bob seconded the motion and the motion passed.

#### 6. EE Committee website update

The existing EE Committee page on the City's website has only the required information similar to what all other City committees/boards have. Can we add more to ours and make it a resource for people? Could we add pictures and links?

#### 7. Other Business

Energy Committee Collective – Doria wants to connect with other similar committees to provide assistance to each other and prevent groups from recreating the wheel. It's difficult to know what other
