



ORDINANCE

INCREASING THE FINES FOR STOPPING, STANDING AND PARKING VIOLATIONS

CITY OF NASHUA

In the Year Two Thousand and Five

The City of Nashua ordains that Chapter 13 “Motor Vehicles and Traffic”, Article V “Parking and Stopping”, of the Nashua Revised Ordinances, is hereby amended as follows:

1. In Division 4 “No Parking, Standing, Stopping in Specified Areas”, Section 13-292 “No parking in leased parking spaces in city parking lots”, subsection (b), delete the struck-through language and add the new underlined language as follows:

“(b) Any unauthorized vehicle found parked in posted reserved parking spaces shall be towed at the owner's expense and the owner shall be fined ~~ten fifteen~~ ten dollars (\$10.00) and if such fine is not paid within seven (7) days that fine shall be increased by ten dollars (\$10.00) to a total of twenty-five dollars (\$25.00). Fines shall be paid to the city traffic violation bureau. Any person desiring a hearing shall within seven (7) days make request therefore, whereupon complaint shall be entered in city district court.”

2. In Division 7 “Violations and Penalties”, Section 13-351 “Stopping, standing or parking violations”, subsections (b) and (d), delete the struck-through language and add the new underlined language as follows:

“(b) Any person violating subsection (a)(2) shall be fined ten dollars (\$10.00) and if such fine is not paid within seven (7) days that fine shall be increased by ten dollars (\$10.00) to a total of twenty dollars (\$20.00). Any person violating subsection (a)(1), (3), (4), (5), (6), or (7) shall be fined fifteen dollars (\$15.00) and if such fine is not paid within seven (7) days that fine shall be increased by ten dollars (\$10.00) to a total of twenty-five dollars (\$25.00). Fines shall be paid to the city traffic violation bureau. Any person desiring a hearing shall within seven (7) days make request therefor, whereupon complaint shall be entered in city district court.

“(d) Each owner or operator of a vehicle who violates any provisions of sections 13-216 through 13-220, 13-274 through 13-279, 13-281 through 13-286, or 13-332 through 13-337 may, prior to the closing of business on the next business day after notice of violations was attached to such vehicle, pay to the city traffic violations bureau, as a penalty for and in full satisfaction of such violation, the sum of ~~ten~~fifteen dollars (\$~~10~~15.00), unless a different amount is specified in the section which has been violated, in which case, that amount will be the penalty. If not paid within seven (7) days, the fine shall increase by ten dollars (\$10.00). In the event that the violation is brought into the Nashua District Court, on account of it not having been earlier satisfied as aforesaid, the fine shall be determined by the court in accordance with the limits established in section 1-9.”

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

This ordinance shall become effective at the time of passage.
