



## ORDINANCE

### AMEND SECTION 285-13 "LICENSE TO EXCAVATE"

### *CITY OF NASHUA*

*In the Year Two Thousand and Eight*

*The City of Nashua ordains* that Part II "General Legislation", Chapter 285 "Streets and Sidewalks", Article II "Construction and Repair", Section 285-13 "Licenses to excavate" is hereby amended by adding the new underlined language as follows:

"§ 285-13. License to excavate.

...

H. The board may permit and authorize the division of public works to conduct pilot programs for the excavation and resurfacing of streets to evaluate new technologies, methods, and/or materials."

**ANALYSIS**

This ordinance will permit the Board of Public Works to authorize the Division of Public Works to institute pilot programs to explore alternatives to existing requirements for excavating and repaving streets set forth in NRO 285-13. This would permit the division to utilize and evaluate new technologies and methods. For example, there is an existing proposal for a "Keyhole and Coring" program that involves removing an 18 inch to 24 inch circular pavement core, gravel and fill, then performing the utility repair followed by backfilling and grouting back the original plug.
