## ORDINANCE

AUTHORIZING THE INSTALLATION OF A YIELD SIGN ON MILK STREET AT ITS  
INTERSECTION WITH HILLSIDE DRIVE

### *CITY OF NASHUA*

*In the Year Two Thousand and Eight*

*The City of Nashua ordains* that Part II “General Legislation”, Chapter 320 “Vehicles and Traffic”, Article III “Stop and Yield Intersections”, Section 320-5 “Yield intersections”, subsection C of the Nashua Revised Ordinances, as amended, be hereby further amended by adding the following new underlined language:

**“§ 320-5. Yield intersections.**

C. The following shall be yield intersections:

RSA 47:17 VIII (a). The Board should consult with the City Traffic Engineer to determine if this ordinance is in compliance.
