



ORDINANCE

AMENDING THE PARKING TIME LIMITS ON MAPLE STREET

CITY OF NASHUA

In the Year Two Thousand and Eight

The City of Nashua ordains that Part II “General Legislation”, Chapter 320 “Vehicles and Traffic”, of the Nashua Revised Ordinances, as amended, be and hereby is further amended as follows:

1. In Article X “Parking Time Limits in Non-Parking-Lot Areas”, Section 320-37 “One-hour parking”, add the new underlined language alphabetically as follows:

“§ 320-37. One-hour parking.

...

- E. No vehicle shall be stationed or remain for a period exceeding one hour on any weekday from 6:00 a.m. to 5:00 p.m., except Saturdays, Sundays and holidays, on the following streets:

Name of Street	Side	Location
<u>Maple Street</u>	<u>East</u>	<u>Entire length</u> ”

2. In Article X “Parking Time Limits in Non-Parking-Lot Areas”, Section 320-38 “Two hour parking”, delete the struckthrough language as follows:

“§ 320-38. Two hour parking.

...

- C. Parking shall be limited to two hours daily, 6:00 a.m. to 6:00 p.m., except Sundays and holidays, on the following streets:

Name of Street	Side	Location
Maple Street	East	From West Hollis Street to Mulberry Street
Maple Street	North	Between Elm Street and Middle Street”

ORDINANCE

3. In Article XII “Parking Stopping and Standing”, Section 320-69 “No parking on certain streets”, add the new underlined language alphabetically as follows:

“§ 320-69. No parking on certain streets.

No parking whatsoever shall be permitted on the following streets, except as provided by law:

Name of Street	Side	Location
<u>Maple Street</u>	<u>West</u>	<u>Entire length”</u>

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

This ordinance shall become effective at the time of removal or installation of the necessary sign(s).
