



ORDINANCE

UPDATING THE REFERENCE TO THE VERSION OF MASON'S MANUAL OF LEGISLATIVE PROCEDURE USED BY THE BOARD OF ALDERMEN

CITY OF NASHUA

In the Year Two Thousand and Ten

The City of Nashua ordains that Part I “Administrative Legislation”, Chapter 5 “Administration of Government”, Part 2 “Board of Aldermen”, Article III “Rules and Order of Business”, Section 5-24 “Other applicable rules”, Subsection A, of the Nashua Revised Ordinances, as amended, hereby be further amended by deleting the struck-through language and adding the new underlined language as follows:

“§ 5-24. Other applicable rules.

- A. Except in cases covered by the City Charter or other ordinances of the City, the rules in Mason's Manual of Legislative Procedure, 1989~~2000~~ Edition, shall govern the proceedings of the Board of Aldermen.”

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

This ordinance shall take effect following its passage.
