



## ORDINANCE

### AMENDING THE DEFINITION OF A "SECONDHAND DEALER"

#### *CITY OF NASHUA*

*In the Year Two Thousand and Nine*

*The City of Nashua ordains* that Part I "Administrative Legislation", Chapter 220 "Pawnbrokers and Secondhand Dealers", Section 220-2 "Definitions" of the Nashua Revised Ordinances, as amended, be hereby further amended by adding the new underlined language as follows:

#### **"§ 220-2. Definitions.**

SECONDHAND DEALER – Any person, firm, partnership or corporation whose business is the retail buying, selling, buy-back, exchanging, dealing in or dealing with secondhand articles, including but not limited to jewelry, watches, clocks, diamonds or other precious stones or gems, gold, silver, platinum, other precious metals, musical instruments and equipment, cameras, furs, fur coats or other kinds of wearing apparel, television, DVD players, video cassette recorders and other electronic equipment, tools, computer and computer equipment, firearms, auto accessories and office and store fixtures and related equipment.

However, the definition of Secondhand Dealer shall not apply to any person, firm, partnership, or corporation who do not purchase secondhand articles directly from the general public.”

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

This ordinance shall take effect following its passage.
