



## ORDINANCE

ESTABLISHING A 25 M.P.H. SPEED LIMIT ON LAWNDALE AVENUE

### *CITY OF NASHUA*

*In the Year Two Thousand and Ten*

*The City of Nashua ordains* that Part II “General Legislation”, Chapter 320 “Vehicles and Traffic”, Article VI “Speed Limits”, Section 320-23 “Speed limit signs”, subsection B of the Nashua Revised Ordinances, as amended, be hereby further amended by adding the following new underlined language in the appropriate alphabetical order:

**“§ 320-23. Speed limit signs.**

...

B. The following streets shall have a speed limit as indicated:

Name of Street	Speed Limit (mph)	Location
<u>Lawndale Avenue</u>	<u>25</u>	<u>Entire length”</u>

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

This ordinance shall become effective at the time of removal and/or installation of the appropriate sign(s).

**ANALYSIS**

This ordinance establishes a 25 m.p.h. speed limit on Lawndale Avenue.

NH RSA 265:63 allows the board of aldermen to pass this legislation if the board determines, on the basis of an engineering or traffic investigation that the prima facie speed normally permitted by NH RSA 265:60 and NRO 320-23 is greater or less than is reasonable and safe under the conditions found to exist upon these streets. The speed limit for these streets may not be decreased to less than 25 mph. NH RSA 265:63.
