



## ORDINANCE

### CORRECTING AND UPDATING SEVERAL ITEMS OF ADMINISTRATIVE LEGISLATION

### *CITY OF NASHUA*

*In the Year Two Thousand and Ten*

*The City of Nashua ordains* that Part I “Administrative Legislation” of the Nashua Revised Ordinances, as amended, is hereby further amended as follows:

1. In Chapter 50 “Personnel”, Article VIII “Workers’ Compensation”, Section 50-35 “Self-insurance fund”, subsection A(2), delete the phrase “long-term disability programs,”.
2. In Chapter 5 “Administration of Government”, Part 4 “Officers and Employees”, Article XIII “Generally”, Section 5-58 “14 Court Street Commission”, subsection B, delete the phrase “Administrative Services Division Director or his or her designee” and replace it with the phrase “Financial Services Division Director/CFO or designee”.
3. In Chapter 5 “Administration of Government”, Part 4 “Officers and Employees”, Article XIII “Generally”, Section 5-59 “Joint Employee/Administration Health Insurance Advisory Committee”, subsection B, delete the phrase “Director of the Administrative Services Division or designee” and replace it with the phrase “Mayor or designee”.

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

This ordinance shall take effect following its passage.
