



ORDINANCE

UPDATING THE PARKING RESTRICTIONS ON CENTRAL STREET

CITY OF NASHUA

In the Year Two Thousand and Thirteen

The City of Nashua ordains that Part II “General Legislation”, Chapter 320 “Vehicles and Traffic”, Article X “Parking Time Limits in Non-Parking Lot Areas” of the Nashua Revised Ordinances, as amended, be hereby further amended by deleting the struck-through language and adding the new underlined language in the appropriate alphabetical order as follows:

1. In Section 320-35 “Fifteen-minute parking”:

“§ 320-35. Fifteen-minute parking.

- A. No vehicle shall be stationed or remain for a period exceeding 15 minutes on the following streets:

Name of Street	Side	Location
...		
<u>Central Street</u>	<u>South</u>	<u>From Chestnut Street westerly for a distance of 95 feet</u>
<u>Central Street</u>	<u>South</u>	<u>From Palm Street easterly for a distance of 116 feet”</u>

2. In Section 320-36 “Thirty-minute parking”:

“§ 320-36. Thirty-minute parking.

No vehicle shall be stationed or remain for a period exceeding 30 minutes on the following streets:

Name of Street	Side	Hours	Location

<u>Central Street</u>	<u>South</u>	<u>All</u>	<u>From Chestnut Street westerly for a distance of 95 feet”</u>

3. In Section 320-37 "One-hour parking":

"§ 320-37. One-hour parking.

- A. No vehicles shall be stationed or remain for a period exceeding one hour from 9:00 a.m. to 6:00 p.m. on the following streets:

Name of Street	Side	Location

Central Street	North	Between Pine Street and Palm Street"

4. In Section 320-38 "Two-hour parking":

"§ 320-38. Two-hour parking.

- C. Parking shall be limited to two hours daily, 6:00 a.m. to 6:00 p.m., except Sundays and holidays, on the following streets:

Name of Street	Side	Location
...		
Central Street	South	Between Pine Street and Walnut Street"

- D. Parking shall be limited to two hours daily, 6:00 a.m. to 6 p.m., except Saturdays, Sundays and holidays, on the following streets:

Name of Street	Side	Location
...		
Central Street	North and south	From Pine Street east to Chestnut Street"
<u>Central Street</u>	<u>South</u>	<u>From Pine Street east to Palm Street, then from 116 feet east of Palm Street to 95 feet west of Chestnut Street"</u>

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

This ordinance shall become effective at the time of removal and/or installation of the necessary sign(s).
