



ORDINANCE

ELIMINATING THE PARKS AND RECREATION ADVISORY COMMITTEE AND THE SERVICES ADVISORY COMMITTEE FOR CENTRAL BUSINESS SERVICE DISTRICT

CITY OF NASHUA

In the Year Two Thousand and Fourteen

The City of Nashua ordains that Part I “Administrative Legislation” of the Nashua Revised Ordinances, as amended, be hereby further amended by:

1. In Chapter 5 “Administration of Government”, Part 5 “Conduct Regulations”, Article XVIII “Ethics Rules”, Section 5-94 “Designation of special municipal employees”, subsection B (14), delete the struck-through language and renumber the remaining subsections appropriately:

“B. All members of the following boards and commissions, other than full-time City employees:

(14) ~~—Parks and Recreation Advisory Commission.”~~

2. In Chapter 12 “Boards, Committees and Commissions”, Article V “Parks and Recreation Advisory Committee”, delete the struck-through language:

~~“ARTICLE V~~

~~Parks and Recreation Advisory Committee~~

~~§ 12-14. Establishment; purpose.~~

~~A Parks and Recreation Advisory Committee is hereby established. The Committee shall be responsible for making recommendations to the Parks and Recreation Department for the improvement and maintenance of City parks and recreational programs.~~

~~§ 12-15. Membership; terms.~~

~~A. —The Committee shall consist of seven members.~~

- ~~(1) — One member shall be the Associate Manager of Parks Maintenance.~~
- ~~(2) — One member shall be the Associate Manager of Recreation Services.~~
- ~~(3) — Two members shall be members of the community, who shall be appointed by the Mayor and confirmed by the Board of Aldermen.~~
- ~~(4) — The remaining three members shall be members of the community, who shall be appointed by the President of the Board of Aldermen and confirmed by the Board of Aldermen.~~

~~B. — The community committee members will serve three year terms. However, the initial appointments of the community committee members will be two members for one year and three members for two years.~~

~~§ 12-16. Chairperson; bylaws; meetings.~~

~~The Committee shall elect a Chairperson from among its members. The Committee shall establish its bylaws and establish regular times for meetings and the orderly conduct of business.~~

~~§ 12-17. Compensation.~~

~~The members of the Committee shall serve without compensation.”~~

3. In Chapter 12 “Boards, Committees and Commissions”, Article X “Services Advisory Committee for Central Business Service District”, delete the struck-through language:

~~“ARTICLE X~~

~~Services Advisory Committee for Central Business Service District~~

~~§ 12-35. Composition.~~

~~There shall be a Services Advisory Committee for the Central Business Service District composed of seven members. Six of the members shall be appointed by the Mayor and confirmed by the Board of Aldermen, not less than five of whom shall be owners or tenants of property within the proposed Central Business Service District. These six members of the Advisory Committee shall serve for terms of three years. The seventh member of the Committee shall be a member of the Board of Aldermen, appointed by the President and approved by the Board of Aldermen, who shall serve for a term coterminous with the biennial term of the Board of Aldermen.~~

~~§ 12-36. Duties.~~

~~The Services Advisory Committee shall consult with the Mayor and Board of Aldermen on the boundaries of the Central Business Service District, specific services and level of~~

~~services to be provided in the district, and which specific department, agency, or other party is to undertake the work, all of which shall be determined by the Mayor and Board of Aldermen.”~~

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

This legislation shall take effect following its passage.
