



## ORDINANCE

RELATIVE TO THE BUDGET REVIEW COMMITTEE INVITING THE  
SUPERINTENDENT OF SCHOOLS TO MEET QUARTERLY

### *CITY OF NASHUA*

*In the Year Two Thousand and Eleven*

*The City of Nashua ordains* that Part I “Administrative Legislation”, Chapter 5 “Administration of Government”, Part 2 “Board of Aldermen”, Article II “General Provisions” of the Nashua Revised Ordinances, as amended, be hereby further amended by adding the following new section:

**“§ 5-9.1. Budget review committee and superintendent of schools.”**

The chair of the budget review committee is encouraged to invite the superintendent of schools, on a quarterly basis, to attend a budget review committee meeting to update the committee on school news and budget expenditures to date.”

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

This ordinance shall take effect following its passage.
