**RESOLVED** by the Board of Aldermen of the City of Nashua that the City of Nashua and the Division of Public Health and Community Services are authorized to accept and appropriate an additional \$54,232 from the State of New Hampshire Department of Health & Human Services Department into Special Revenue Account #341-6457 "FY 2011 Emergency Preparedness Grant Amendment" for the purpose of continuing activities for emergency preparedness and response capacity within the Nashua region.
