



## RESOLUTION

**RELATIVE TO THE ACCEPTANCE AND APPROPRIATION OF AN ADDITIONAL \$121,440 OF FEDERAL FUNDS INTO DPW CAPITAL PROJECTS ACTIVITY "LOOP TRAFFIC SIGNAL SYSTEM EXPANSION" FROM THE STATE OF NEW HAMPSHIRE DEPARTMENT OF TRANSPORTATION**

### *CITY OF NASHUA*

*In the Year Two Thousand and Fourteen*

**RESOLVED** by the Board of Aldermen of the City of Nashua that the City of Nashua and the Division of Public Works are authorized to accept and appropriate an additional \$121,440 (80%) of Federal Funds from the State of New Hampshire Department of Transportation into DPW Capital Projects Activity "Loop Traffic Signal System Expansion" for the purpose of completing the expansion of the closed loop traffic signal system of the City's existing traffic management center. These funds are in addition to the amount of \$1,864,000 previously authorized under R-10-018. The City's 20% share is \$24,288, funded through Fund #7514 "Amherst Street Transportation Improvements ETF" (\$12,362) and General Fund Dept #161 "Street Department" Account #55 "Other Services" (\$11,926).
