**RELATIVE TO THE TRANSFER OF \$18,390 INTO VARIOUS CITY CLERK
ACCOUNTS TO COVER EXPENSES FOR THE MUNICIPAL SPECIAL ELECTION
ON JUNE 23, 2015**

In the Year Two Thousand and Fifteen

WHEREAS the Board of Aldermen has ordered that warrants be issued for a municipal special election to be held on June 23, 2015; and city charter section 24 requires that the cost of municipal elections provided for in the charter be appropriated for such elections;

NOW THEREFORE, BE IT RESOLVED by the Board of Aldermen of the City of Nashua that the sum of \$18,390 be transferred from:

Department 102 – Board of Aldermen, General Fund Operating Budget
Accounting Classification 51 Salaries & Wages - \$1,875
Department 130 – Purchasing, General Fund Operating Budget
Accounting Classification 51 Salaries & Wages - \$16,515

into:

Department 107 City Clerk, General Fund Operating Budget,
Accounting Classification 51 Salaries & Wages - \$15,975
Accounting Classification 53 Professional & Technical Services - \$1,480
Accounting Classification 55 Other Services - \$835
Accounting Classification 61 Supplies & Materials - \$100

for the purpose of covering expenses for the June 23, 2015 municipal special election.

ANALYSIS

This resolution authorizes the transfer of \$18,390 from the two named accounts into the City Clerk General Fund Operating Budget to cover the expenses of the June 23, 2015 municipal special election. Under Charter Section 24, the funds are to be appropriated at the time the Board of Aldermen orders the warrants to be posted.

A resolution which sets the date, polling hours, and time period for filing nomination petitions for the June 23, 2015 municipal special election and issues precepts to the selectmen of the city wards is being introduced contemporaneously.

Charter Sec. 53 permits the Board of Aldermen to transfer any unencumbered appropriation balance or any portion thereof from one department, fund or agency to another.

NRO § 5-130, H provides that "when proposed legislation to transfer or reappropriate a particular appropriation or portion thereof has had its first reading, such funds shall not be expended or transferred while the legislation is pending".
