



ORDINANCE

AUTHORIZING STOP SIGNS AND RIGHT AND LEFT TURN ONLY LANES AT THE INTERSECTION OF PINE HILL ROAD AND CHARRON AVENUE

CITY OF NASHUA

In the Year Two Thousand and Eighteen

The City of Nashua ordains that Part II “General Legislation”, Chapter 320 “Vehicles and Traffic” of the Nashua Revised Ordinances, as amended, be hereby further amended by adding the following new underlined language in the appropriate alphabetical order:

1. In Article III “Stop and Yield Intersections”, Section 320-4 “Stop intersections”, subsection D:

“§ 320-4. Stop intersections.

...

- D. The following intersections are hereby designated as stop or through streets, and authority is hereby granted for the erection of a stop sign at the corner so designated in accordance with the tenor of this chapter:

2. In Article IV “Turning Movements”, Section 320-17 “Right lane for right turn only”:

“§ 320-17. Right lane for right turn only.

At the following intersections, the right lane shall be used only for right turns:

Name of Street	Direction of Travel	Right Turn Only Onto
<u>Charron Avenue</u>	<u>Southerly</u>	<u>Pine Hill Road</u>

<u>Pine Hill Road</u>	<u>Westerly</u>	<u>Charron Avenue”</u>

3. In Article IV “Turning Movements”, Section 320-18 “Left lane for left turn only”:

“§ 320-18. Left lane for left turn only.

At the following intersections, the left hand lane shall be used only for left turns:

Name of Street	Direction of Travel	Left Turn Only Onto
<u>Charron Avenue</u>	<u>Southerly</u>	<u>Pine Hill Road”</u>

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

This ordinance shall become effective at the time of removal and/or installation of the necessary sign(s) and/or device(s).

ANALYSIS

This legislation authorizes stop signs at the intersection of Pine Hill Road and Charron Avenue to make the intersection an all-way stop. The stop sign on Charron Avenue currently exists. There will also be an exclusive right turn lane traveling westerly on Pine Hill Road turning onto Charron Avenue, as well as right and left turn only lanes coming out of Charron Avenue onto Pine Hill Road.

The erection, removal and maintenance of all traffic control devices must conform to applicable state statutes and the latest edition of the manual on Uniform Traffic Control Devices. RSA 47:17 VIII (a). The Board should consult with the city's Traffic Engineer to determine if this ordinance is in compliance.
